

## Hinchey Tells of Seeing Frank On Car on Day of the Murder

H. J. Hinchey, of 391 Peachtree street, a business acquaintance of Leo Peachtree street, a business acquaintance of Leo Frank, and manager of the South At-lantic Blow Pipe company was put upon the stand by the detense. He stated having seen Frank on the mur-der date as the superintendent rode into town on a Washington street, trolley car, meeting him at Washing-ton and Hunter streets. He was questioned by Mr. Arnold, "Do you recollect April 26, Memorial day?"
