The men gave the names of M. V. Lee, of Hapeville; T. W. Atkinson, of 311 Whitehall street, and W. A. Norton, of 50 1/2 South Forsyth street...

It is alleged that Lee and Norton were the dispensers of the liquor, while Atkinson was used as a "rustler" of business and delivery boy.

The detectives further declare that one of the clubs which was closed during the afternoon is involved in the source from which these men got their liquor.

The detectives stated that they have evidence which will bring about other arrests and convictions. The case against Atkinson, Lee and Norton is scheduled to be heard in recorder's court Tuesday.

TROOPS ON GUARD TO SAVE NEGROES FROM JUDGE LYNCH

Enraged Citizens Are Rushing to Waynesboro Bent on Avenging the Brutal Murder of Mrs. Irby.

Martial Law Is in Force in Waynesboro—Crowds of Men Reported to Be Approaching the Town.

Augusta, Ga., December 15.—(Special.)—At 2:30 this morning a telephone message from Waynesboro stated that the town had been placed under martial law in an effort to protect the three negroes accused of murdering Mrs. Irby.

A party from Louisville and another from Wrens were stopped about a mile from the jail and detained by the militia.

The prisoners have been removed from the jail building proper, and are now in possession of the militia, under strong guard.

The negroes are Robert Paschal, Sam Irby and a third whose name is not known. They were brought to Waynesboro this afternoon from Louisville by the sheriff of Jefferson county, who slipped away from a mob which was bent upon lynching the three men.

It was thought that they were to be safe in the Burke county jail here, but stories of the unusual brutal nature of the crime with which the negroes were charged, brought in after the arrival of the sheriff and his prisoners, led to threats of violence, which caused the sheriff to return to Waynesboro.

The local company got to the jail in record time, and the building was surrounded by an angry crowd, composed largely of men from Jefferson county, where the crime was committed.

At midnight the negroes are in the jail with a large number of armed deputies, while the militia is on guard around the building.

The crime with which the negroes are charged was committed yesterday afternoon above Wrens, near the Glascock county line, when three negroes, Robert Paschal, Sam Irby and another whose name is not known, went to the house of Seth Irby, a white man, attacked his wife, cut her head from her shoulders and beat it into a jelly.

When Irby returned home from a visit he had made to a neighbor nearby he found his family of small children covered up in bed frightened nearly to death, the headless body of his wife lying on the floor.

One story of the murder is that the negro Irby, in company with the others, went to the home of Mr. Irby about sundown yesterday afternoon, and in his absence, demanded of his wife payment for some potatoes he claims to have sold Mr. Irby. She refused to pay him and he killed her.

While her mother was preparing breakfast she retired to a room, took carbolic acid and was dead in a few minutes.

Heath Foy, son of Sam Foy, in the upper part of this county, committed suicide this morning by shooting himself with a shotgun.

WILSON WINNING IN MONEY FIGHT

First Test of Strength on the Currency Bill Shows Administration in Control.

Washington, December 15.—Victory for the administration forces in the first test of strength on the currency reform bill marked today's session of the senate.

The defeat of this amendment practically assured the adoption of the Owen plan, which provides for from eight to twelve regional banks, with that become members of the respective regional banks.

Efforts to get an agreement for a time to begin final voting on the bill were not successful today, but leaders on both sides of the chamber looked to an early termination of the debate and for final action before the end of the week.

When the Hitchcock substitute had been tabled Senator Reed made a speech vigorously denouncing the Owen bill and replying to Senator Root, who on Saturday attacked the measure and called Secretary Bryan "the dominating influence" behind the proposed new currency system.

Repeating directly to Senator Root's predictions that undue inflation and a financial panic might ensue if its present form, Senator Reed declared no inflation of the currency could occur unless the "sound money men who run the banks" brought it about.

Senator Reed said a "typewritten document" proposing Senator Root for the presidency had been prepared and given to the press before he made his speech.

"No one has the right to stand on the floor of the senate and undertake to alarm the business interests of the country when there is no just cause for it. I doubt the high patriotism of the man who will stand here and cry, 'Wolf, wolf,' when there is no wolf, who will take this chance of injuring the multitude who may be misled by such a cry."

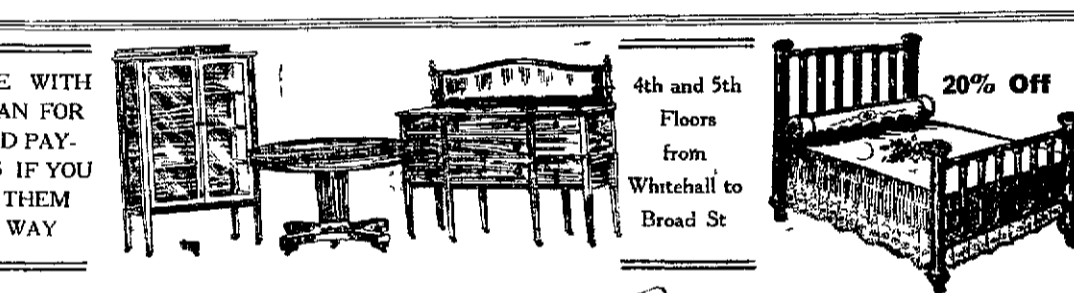

HUERTA TO RULE AS HE PLEASURES

Congress Adjourns After Granting Huerta Dictatorial Powers—Congress to Meet Again Next April.

Mexico City, December 15.—From now until April 2, President Huerta will be obliged to conduct the government without congress, as that assembly adjourned today. Its most important acts during the session were the ratification of the president's assumption of power over the various departments of the government after dissolving the preceding congress, and recommending to the president this same power, which gave General Huerta, until congress convenes again, practically the sway of a dictator.

Altogether the new congress was unobtrusive, interfering not at all with the executive's ideas of government. Its most notable act, aside from those directly connected with the executive plans, was the ratification of a convention to construct 5,000 miles of narrow gauge railway.

The rebel General Villa's treatment of the Spaniards at Chihuahua has aroused the keen sympathies of the colony here. The Spanish minister, Senor Colagan Y. Colagan, sent to Washington today, through the American charge, Neilson O'Shaughnessy, his thanks for the efforts made by

the government to relieve his countrymen at that place.

The situation around Tampico is declared by the government to be satisfactory. Late railway reports indicate that the rebels in their retreat took away only four locomotives and enough cars to make up four trains. Reports from other parts of Mexico concern the usual number of minor engagements and bold depredations.

WASHINGTON MOVING TO AID FOREIGNERS

Washington, December 15.—Except for a telegram from American Consul Letcher telling of threats of expulsion of Spaniards and confiscation of their property, the state department up to late today had received no official information concerning reported indications to other foreigners by Mexican rebels at Chihuahua City.

Secretary Bryan said that there had been no interference with Consul Letcher's telegram by the constitutionalist and that so far as he had been able to learn no threats had been made against any of the foreign consuls.

The secretary announced that on account of a break in the wire communication between Chihuahua and Juarez American Consul Edwards at the latter place had decided to avail himself of the services of G. L. Carver, consular agent at Torreon, who arrived at El Paso today, to go back to his post by way of Chihuahua. Mr. Carver is to carry any communications which Mr. Edwards has and will assist Mr. Letcher at Chihuahua until the situation is normal there.

No instructions to Consul Letcher beyond those sent on Saturday as a result of representations by the Spaniards on previous occasions, were dispatched by the state department. The telegram to Mr. Letcher was described by Mr. Bryan as containing the usual sort of representations that have been made to General Carranza and General Villa on previous occasions, emphasizing the importance of respecting foreigners and their property. Mr. Letcher was also instructed to refer to summaries of action taken with reference to Luis Terrazas, Jr., the wealthy land owner, reported to have

been taken forcibly from the British consulate by Villa's men.

LOAN OF \$10,000,000 SECURED BY HUERTA

Mexico City, December 15.—The Imperial today quotes an anonymous banker as stating that what the present government has secured a loan of \$10,000,000 from English capitalists.

GENERAL VILLA FEARS TRAP BY THE FEDERALISTS

Juarez, Mexico, December 15.—While the federalists in Juarez today were sending urgent messages to General Francisco Villa, the rebel commander at Chihuahua, telling him he was incurring the displeasure of foreign countries in his actions toward Spaniards, the federalists were asking him to modify his attitude. General Villa himself was said to be seriously concerned over renewed federal attacks.

Reports were that federalists were advancing toward Chihuahua from Torreon, about 50 miles south, but he had to scatter his forces by sending troops to surround the federalists at Ojinaga, and Chihuahua. This was said to offer the federalists an opportunity to strike at Chihuahua, which was frequented by them when Villa had all his forces together. Federal troops were also reported on their way from Monterrey to Ojinaga, where the federalist position of the Huerta government in the interior.

BANKS COUNTY MAN IS HELD ON CHARGE OF WHITE SLAVERY

A federal deputy marshal from Fort Worth, Texas, reached Atlanta yesterday, bringing to the custody of the United States court for the northern district of Georgia, John B. Sellers, a native of Banks county, who is under indictment found by a federal grand jury at Columbus a few weeks ago, charging white slavery.

In October, last, Sellers was a resident of Banks county, 12 miles from Cornelia, a husband and father of four children. Suste Coker, a comely girl of 17 years, lived with his parents on an adjoining plantation. The Sellers family and the Coker family were "next-door" neighbors. No one knew, until after October 1st, that the married man and the girl were more than friendly neighbors, as is now charged.

On that night it is claimed, the girl stole from her bedroom after the family was asleep, and went to a waiting automobile in which Sellers was waiting, and drove into Athens, where he and his companion jumped into another automobile and began a hurried run to Atlanta.

From Atlanta the pair took a train, it is said, to Macon, where they passed the night before going to Columbus, where the matter was taken before the federal grand jury. From Columbus, federal authorities say, Sellers and the girl went to Oklahoma, and Sellers' money gave out and the man and woman went into a cotton field side by side for a few days as cotton pickers.

It is said to have given the girl a ticket to Mineral Springs, a short distance away, and 45 cents in money, told her to skip and never bother him again. The girl wrote to her parents and the letter was the first information they had had from the girl. The father came to Atlanta and laid the matter before the federal authorities.

L. J. Bailey, local representative of the federal department of justice, located the girl in Texas and brought her back to Georgia to her parents, and a search was instituted for Sellers. He was found about two weeks ago in Texas and was committed to the Fort Worth, Texas, jail to await an order of transfer by the federal court to Georgia. Sellers asserts he will be able to make bond as soon as the price is fixed.

TWO-YEAR SENTENCE IS GIVEN CARTER

Man Who Tried to Organize Bank in Atlanta Sent to Pen.

John H. Carter, whose banking speculations in Georgia were all but consummated in the organization of a million dollar bank in Atlanta some years ago, was sentenced in Ellijay, Ga., to two years in the state penitentiary. Some two months ago Carter was indicted by the grand jury at Ellijay and upon being informed that an indictment had been made against him he surrendered to the authorities and gave bond for his appearance in court. Carter lived in Asheville, N. C., and has a family. His brother is ex-supreme court judge in Florida.

The trial at Ellijay last week was instigated through the efforts of the five banks of this state of which Carter at one time had control. The banks are the North Georgia bank and the North Georgia Trust company, of Blue Ridge; the Gilmer County bank, of Ellijay; the Bank of Jasper; the Bank of Dalton; and the Bank of Ducktown. Carter also controlled the Bank of Murphy, N. C.

The charge upon which Carter was tried at Ellijay was embezzlement of \$5,500 worth of the Ellijay bank's stock. Carter was prosecuted by Judge Jackson Gober, of this city.

There are indictments out against Carter, so it is said, at Asheville, in the federal courts, where he has been indicted on over a score of counts. The charges there are that Carter took over \$140,000 worth of the bank's funds for speculative purposes.

TAXI FARE TO BE REGULATED BY LAW

Councilman Roy Abernathy's ordinance regulating the rates of taxi cabs was approved by council yesterday afternoon. Councilman Shepard opposed the ordinance, explaining that he believed members of council should be furnished copies in order that they might study the provisions.

The rates are as follows: For the first half-mile, 50 cents; one mile, 75 cents; one and one-half miles, \$1; two miles, \$1.25; two and one-half miles, \$1.50; and 25 cents for each passenger more than one.

The new rates by the hour are \$3.50 for a five-passenger auto for the first hour and \$3 for each hour thereafter, and \$4 an hour for a seven-passenger car for the first hour and \$3.50 for each hour thereafter.

Objection was raised by some owners of automobiles to the hour rates. They obtained an amendment by having the hour rate increased.

The ordinance provides that rates must be posted in all automobiles for rent.

TAKES LIFE OF MAN WHO INSULTED WIFE

Alfred Dyer, of Leary, Killed by Jerome Clemmons—Both Are Well Known.

Leary, Ga., December 15.—(Special.) Alfred Dyer, a sawmill man, was shot and instantly killed here last night by Jerome Clemmons, a well-known citizen of this town.

It is stated that Dyer, who had been drinking, made an insulting remark to Mrs. Clemmons on the street yesterday evening and when the matter reached Clemmons' ears he threatened violence to Dyer. When the latter learned of Clemmons' statement, he strapped a couple of revolvers to his waist and went to the Clemmons residence. Clemmons stopped out with a repeating shotgun in his hand and pumped Dyer's body full of lead, literally shooting it to pieces. Clemmons surrendered to the authorities.

Dyer was from Turnerville, Ga., where he had a family. The body was shipped there for burial.

BLOW FROM BELT RESULTS IN DEATH OF ROME EMPLOYEE

Rome, Ga., December 15.—(Special.) The breaking of a big leather belt on one of the machines of the Rome Furniture and Manufacturing company this afternoon caused the death of Frank Wood, a trusted employee of the company. The belt struck Wood, who was standing on a ladder nearby, and the force of the blow knocked him to the floor, causing two fractures of the skull and concussion of the brain. He was taken to a local hospital, but died without regaining consciousness.

Wood was 45 years of age and had been at the factory for fifteen years. He is survived by a wife and daughter. His funeral will take place tomorrow.

RAILROADS MUST SHOW REASON WHY

Withdrawal of Mileage Is Held Violation of Commission Rule, and Carriers Are Called On to Explain

After an executive session lasting throughout the entire day, the Georgia railroad commission came to the conclusion yesterday that the railroads in taking out their interchangeable mileage books had violated Order No. 14 of the commission and an order was issued requiring the roads by January 15, 1914, to show cause why they had violated said order and why the commission should not certify the violation to the governor and ask him to bring suit against the roads as the law requires.

The order which it is claimed that the railroads violated required that carriers before making any changes in tariffs, whether such tariffs are the required changes of the commission or whether they are voluntary concessions on the part of the roads to the traveling public, first submit the same to the commission in the order that they may be passed upon by it.

Following the judgment of the railroad commission requiring the roads to pull mileage books in violation of the order which is held to be a violation of the commission's rule, the commission was divided three to two on the original order. 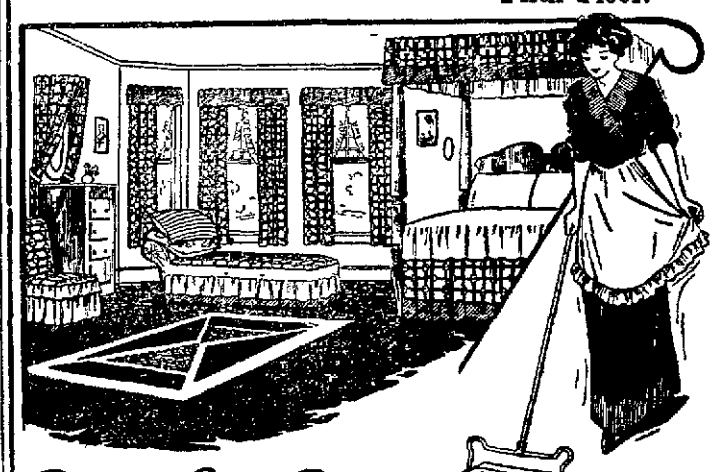

Southern League Season Opens April 15; Schedule Committee Named--Atlanta Gets Holiday Dates--Spring Meet at Mobile

The Southern league season of 1914 will open on Wednesday, April 15, the schedule committee has been instructed to draft two schedules, one calling for 140 games, and the other for 150. They were further instructed to submit these schedules to the league meeting in the spring, at which time will come the decision as to which season the league will open in the fall and to increase the season the same length or to increase it.

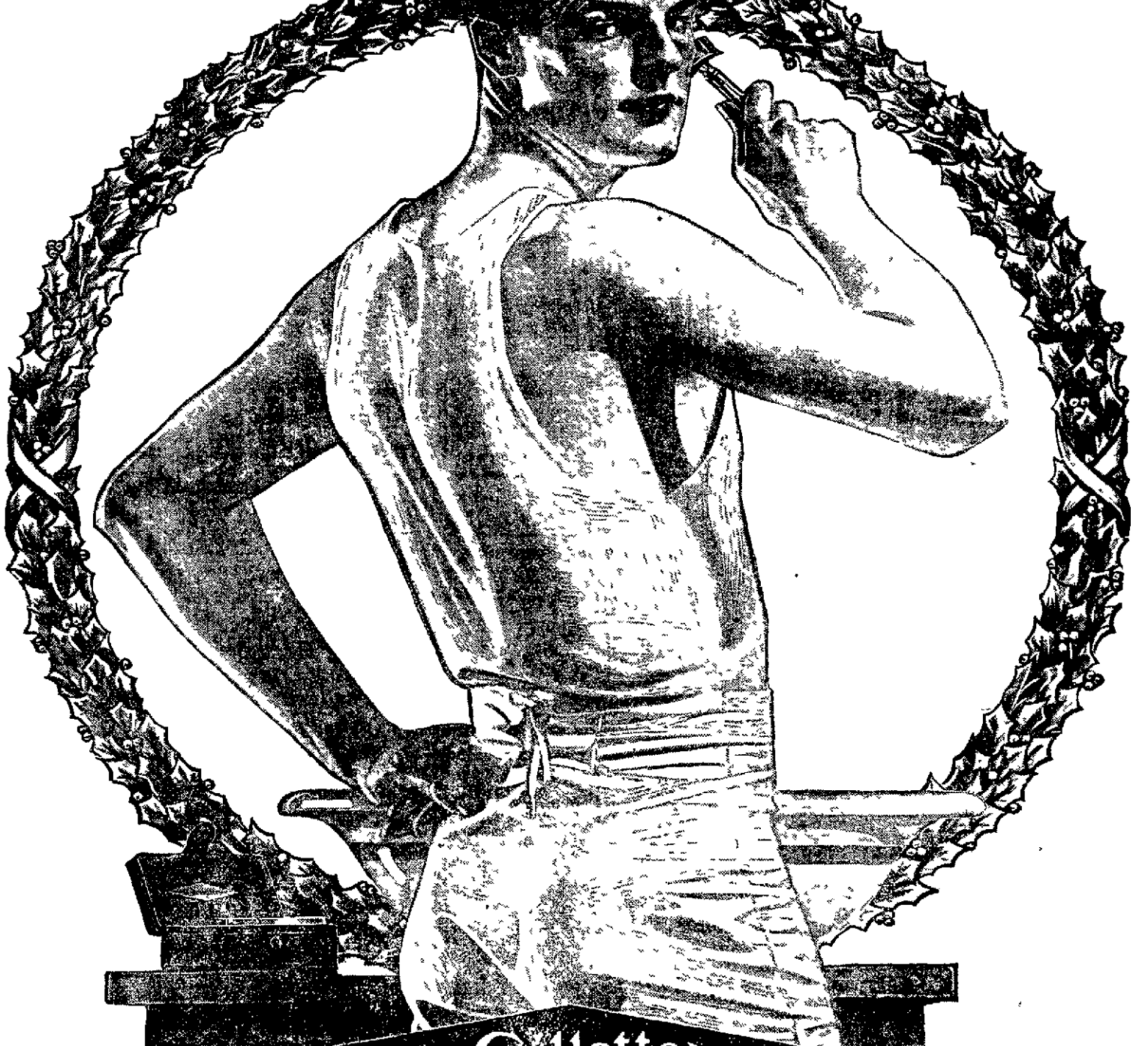
