NO LAMAR DECISION YET.

Justice Expected to Rule on Frank Writ Appeal This Week.

26.—Justice WASHINGTON. Dec. Lamar of the Supreme Court of the United States, who has had under advisement since Thursday the appeal of Louis Marshall of New York from the Georgia District Court's denial writ of habeas corpus to Leo M. Frank, under sentence of death at Atlanta, has not yet handed down his decision. Information that he would not do anything before "next week" is taken to mean that he may not give his decision for four or five days.

The Supreme Court is now in recess and Justice Lamar heard Mr. Marshall's

argument in chambers.

WOMAN'S BODY IN MEADOWS.

Mrs. Joseph Burries, Missing Since Nov. 21, Found Dead in Jersey.

Mr. Burries was notified, and, although he was just convalescing from an operation on his shoulder in a New York hospital, he insisted on getting out against the advice of his physician and making the trip. cian and making the trip to Harrison. There he identified the body as that of his wife. Mr. Burries, who is connected with a

warehouse company, said that his wife was seemingly happy at home and that he was unable to explain the strange attraction which had led her three times to wander away to the Kearny meadows. She was 44 years old and left two sons, aged 15 and 11 years. **FELL 14 FEET WHILE ASLEEP**
